

## Somerset Local Food Limited: Community Share Application Form On behalf of a child under the age of 16

You may apply for a minimum of 100 shares of £1 i.e. you need to invest at least £100. Although the legal maximum for buying shares in a Community Benefit Society is £100,000, the maximum investment in Somerset Local Food Limited is capped at £25,000.

A person under 16 cannot be a member. But a member can hold shares on behalf of somebody who is under 16. The Society will treat those shares as belonging to that member (and not the child). Following the child's 16th birthday, they may become a member of the Society and those shares can be passed on to them. The member must contact the Society to arrange the transfer of the shares.

## Section B: Transfer of shares on death, bankruptcy or mental incapacity.

**For shareholdings of £5,000 or less:** If the member has named a person to take the shares in these events (called the member's nominee) and if the shares registered in the member's name have a total value of £5,000 (or less), then the society will transfer the shares to the member's nominee.

**For shareholdings greater than £5,000:** If the member has named a person to take the shares in these events (called the member's nominee) and if the shares registered in the member's name have a total value of more than £5,000, then the society will transfer the shares to the member's nominee, but only for shares with a total value of £5,000. The society will decide which shares transfer to the member's nominee. The member's personal representatives will have to deal with the remaining shares.

***Nominees will only be contacted should the transfer of shares become necessary.***
